Career Life Plan is a new graduation requirement

Effective 2026, high school graduates will need to have a documented Career Life Plan to meet graduation requirements.

The requirement is detailed in Policy 316 Appendix B.

 There will be a <u>course code in Power School</u> that will need to be added to a student's transcript to confirm they have completed the requirements for the Career Life Plan.

What is a Career Life Plan?



Comprehensive education, career, and life plan



Flexible in representation, however, has minimum requirements identified



Requires an ongoing and frequent process over grades 9-12.

2026 graduates however will need to complete the requirements in one year



Intentional and universal learning that supports the new high school experience

Benefits of having a career life plan

Research shows that engaging students in career connected learning is associated with many educational, societal and financial benefits including:

- > bolstering well-being/mental health and satisfaction in life
- > improving academic achievement
- > increasing student engagement and motivation
- ➤ facilitating the development of competencies needed to successfully manage learning, work and transitions
- preparing students for the workplaces of the future
- boosting social mobility
- > improving employee engagement and productivity
- > reducing unemployment
- > strengthening economic growth

Roles

Learners hold the primary responsibility for actively engaging in their Career Life Plan by completing a portfolio, reflecting on growth, and participating in career conversations and experiences. They must also monitor graduation requirements and review their plan in Grade 12 to ensure successful completion.

Educators play a role in bringing career connected learning to life by integrating career pathway planning into instruction and curriculum. They support students by delivering activities, reviewing portfolios and referring learners for additional support when needed

Roles

Resource Team (ESS) collaborate to provide targeted career pathway transition supports for Tier 2 and Tier 3 students by identifying needs, exploring interventions, and sharing best practices. They also connect learners and families with community resources, support portfolio use, and help plan for life after high school.

School Counsellors play an important role in supporting career connected learning, mental health, and well-being by championing career pathway planning. Responsibilities may include career conversations, supporting learners in grades 9–12 and verifying student portfolio completion for graduation.

Administrators support career pathway transition planning to ensure every student successfully completes a Career Life Plan. This includes championing its value, creating universal access, communicating its importance, providing structures and resources.

Implementation Ideas

Due to the wide range of high school compositions, needs and resources, schools have the autonomy to determine how they want to implement the Career Life Plan.

There are several options schools can choose from to ensure their cohort of 2026 graduates will meet the graduation requirement to have a documented Career Life Plan.

School Admin teams will need to consider the specific plan for their 2026 graduation cohort, while also considering what will need to be done to meet the Career Life Plan graduation requirement for their future graduates.

Implementation Ideas: Advisor or Homeroom Periods

Schools can implement, "Career Life Plan" periods throughout the year and use this time to support students on completing the requirements for the Career Life Plan (i.e. Advisor Periods, Specific Career Life Plan Days or Periods).

Schools could include all grade levels in this practice, for the 2026 graduates more oversight may be required to ensure all the requirements of the Career Life Plan are met.

This option could also be partnered with some of the Career Life Plan requirements being embedded in required course curriculum, such as the resume requirement being completed in ELA or the budgeting requirement being completed in Foundations of Math 110.

Implementation Ideas: Specific Career Courses

Students can complete the Career Life Plan requirements by completing a career focused course. These courses will build on the career focused curriculum students had in Personal Wellness 9.

- Career Pathway Design
- Skills for Success 120 (previously Goals, Growth and Grit)
- Career Pathway Mentorship 120 (previously Cooperative Education)
- Essential Skills Achievement Pathway
- Career Connected Experiences 110

It is important that a check is done to ensure the outcomes from the Career Life Plan are embedded in the curriculum outcomes for these courses.


Implementation Ideas: Embed requirements into curriculum

Schools can choose to embed the requirements of the Career Life Requirements into curriculum. This will require developing a way to track student's progress on their Career Life Plan as well as communication amongst staff on when concepts or activities related to the Career Life Plan are occurring so students can be prompted to add items to their portfolios.

- ➤ Personal Wellness 9 is a required course that will help introduce the Career Life Plan to students allowing them to begin to think and plan for their future beyond high school
- > Many courses have elements of the Career Life Plan in their curriculum such as:
 - o resume and cover letter in English Language Arts 111/2/3
 - Financial planning (budgeting) in Foundations of Math 110
 - Experiential Learning opportunities occur in Skilled Trades courses, courses with Labs, career connected courses
